During a meeting with Egypt's Minister of Civil Aviation, the company discussed enhancing cooperation in civil aviation. The proposed logistics city aims to strengthen Egypt's role as a regional and international logistics hub, addressing the growing demand for air cargo services. Gezhouba Group also expressed interest in collaborating on infrastructure projects within Egypt's airport system.





DHL RESEARCH FINDS AI UNLOCKING UNPRECEDENTED LEVELS OF EFFICIENCY AND INNOVATION

DHL's 7th edition of the Logistics Trend Radar highlights the growing impact of Al and sustainability in logistics. The biennial report analyzes 40 key trends, including robotics, IoT, and AI, emphasizing their significance in transforming logistics. Al trends such as Generative AI, AI Ethics, and Advanced Analytics are reshaping data analysis and human-computer interaction. Additionally, sustainability trends like Renewable Energy Sustainable Fuels remain crucial. DHL's Chief Commercial Officer, Katja Busch, and Klaus Dohrmann, Head of Innovation, stress that Al and sustainable supply chains are top priorities for businesses navigating a rapidly evolving industry.

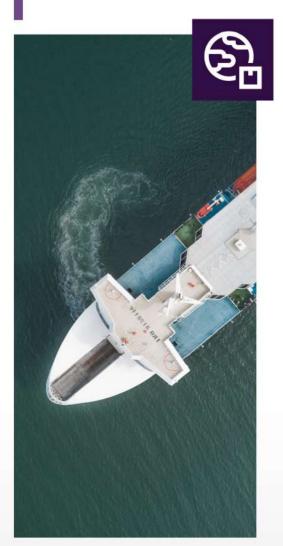
U.S. AND CANADIAN GOVERNMENTS TIGHTEN AIR CARGO SHIPMENT REQUIREMENTS

The U.S. and Canadian governments have implemented new air cargo security measures requiring additional information to be submitted before shipments. This initiative follows warnings from European logistics companies regarding involving "unconventional threats potential incendiary devices" in freight services and incidents involving DHL. The TSA issued a directive mandating air cargo providers to supply detailed information on shippers and consignees to U.S. Customs and Border Protection (CBP) before shipments. The Canadian government has also tightened restrictions on air cargo from certain European and Central Asian countries. While some carriers temporarily suspended shipments to North America, the overall impact on household goods shipments has been minimal, although U.S. government relocations from Europe have experienced wider effects.

NEW LINER SERVICE LAUNCHES CONNECTING SAUDI ARABIA AND INDIA



Folk Maritime Services, part of Saudi Arabia's Public Investment Fund, launched a new liner service connecting Jeddah Islamic Port to India's Mundra and Nhava Sheva ports, starting in September. The 10-day service will use two vessels, boosting trade by transporting Saudi products. including petrochemicals, and Indian consumer goods. A Vessel Sharing Agreement with Oman's Asayd was also signed. This initiative aligns with Saudi Vision 2030's goal of establishing the Kingdom as a global logistics hub. Folk Maritime's CEO. Poul Hestback, emphasized the route as a key step in strengthening Saudi-Indian trade ties. The service offers businesses greater flexibility and sustainable logistics solutions.

ARAMEX PARTNERS WITH SMARTT AI TO **BOOST OPERATIONAL EFFICIENCY**

Aramex, a global logistics leader, has partnered with Smartt Al, an e-commerce solutions provider, to enhance customer experience and operational efficiency using Al-driven technology. The collaboration aims to set new industry standards, offering Aramex's customers Smartt Al's advanced e-commerce solutions.

Key benefits include a unified dashboard for seamless tracking, API integration, and enhanced transparency. Aramex will also offer preferential pricing with a 60% discount and an additional 10% off for Smartt Al customers. Initially launching in the UAE, the partnership will expand to Saudi Arabia and beyond. This collaboration marks a pivotal step toward digital transformation in logistics.

DENMARK'S DSV WINS €14 BILLION BID FOR DEUTSCHE BAHN'S SCHENKER

Danish logistics firm DSV has secured a €14 billion deal to acquire Schenker, the logistics division of German state railway Deutsche Bahn, surpassing rival bidder CVC. The agreement, expected to be signed soon, requires approval from Deutsche Bahn's supervisory board, consisting of government, parliamentary, and union representatives. Despite union opposition due to job loss concerns, the government backed DSV's higher offer. Schenker, with over 70,000 employees worldwide, is Deutsche Bahn's most profitable unit, and its sale will help finance investment in the railway's struggling domestic passenger business and reduce its €30 billion debt. This acquisition would make DSV the world's largest freight forwarder, surpassing Swiss competitor Kuehne und Nagel.
